- 1 Following schedule for the deposit of fee funds etc shall be observed:
 - (a) Without fine

upto 10th of each month

- (b) With fine of Rs. 25/- per day
- upto 20th of each month
- (c) Name shall struck off on 21st of each month if the dues are not paid by 20th
- 2 50% concession in the tuition fee is admissible to the 2nd and 3rd child with the same parentage. The 1st child will pay full tuition fee.
- Students who join the school during the course of the Mid-term of an academic year will be charged full fee and funds from 1st day of April. However in case of student's transfer from another school, the tuition fee will not be charged for the month (s) for which it was paid in the previous school as endorsed on the School Leaving Certificate of the school last attended. Funds will, however be charged.
- 4 Re-admission of students withdrawn on account of non-payment of fee / long absence etc. shall only be considered after clearance of all dues along with payment of prescribed admission fee.
- 5 Parents / Guardians wishing to withdraw their son / ward from the school will give one month's notice clear all the dues / arrear of fees and funds etc. and will also pay the School Leaving Certificate fee of Rs. 25/-.
- The Mess Charges for the period of Summer Vacation will not be charged. In other cases 16 days or more shall be taken as full month while 15 days or less than 15 days shall be taken as half month. Same ratio will be applicable for the new entrants joining the hostel during the month. No concession is allowed or any other occasion during the session.
